1. BEGINNINGS

The Christian Hospital, Bissamcuttack (CHB), founded in 1954 by Dr. Elisabeth Madsen from Denmark, has consistently aimed to provide quality healthcare to the underprivileged community. From its humble beginnings, this hospital has experienced remarkable growth in size, facilities, and staff. Today, it stands proudly as a picturesque 200-bedded hospital situated on a 16-acre campus, nestled amidst the natural beauty of Rayagada District. In addition to its healthcare services, CHB offers two nursing programs, namely the GNM and B.Sc. Nursing courses, as well as an ICSE school called the New Life English Medium School, catering to students from KG1 to Std 10, and MRSK for students in classes 1 to 5.

2. VISION STATEMENT

With guidance from God, personal integrity and commitment, we envision being the best nursing education institution in training nurses from and for Odisha; and to lead the nursing profession to its highest level of excellence

3. CORE VALUES

Core values give us direction and purpose. The following are our core values—caring, compassion, commitment, relevance, excellence, respect, honesty and integrity

4. MISSION

Our mission is to provide leadership in the education of professional nurses to function as health care providers who determine the delivery of nursing and health in its practice and education.

5. PHILOSOPHY

As an institution, we believe in promoting physical, emotional & spiritual health and healing. Nurses form a major component of the health care delivery system. We believe that nursing is a practicing profession and has an important role in promoting health and preventing disease in the hospital and the community. As the progress of our country depends on healthy individuals, we believe that health is a right of every human being. We further believe that providing a good standard of training to young people will prepare them to become responsible nurses and citizens of society. We also believe that through this period the high ideals and values of Christian service will be imparted to them. Since we are situated in one of the most remote and underdeveloped parts of the country, we believe that the people of this area should be given a special opportunity for development.

6. AIM

The faculty and staff of the College of Nursing Christian Hospital, Bissamcuttack desire to develop qualified nurses, who will excel in rendering the best possible nursing care to clients in the hospital and community in the spirit of Christ.

7. OBJECTIVES

On successful completion of the course – the nursing graduate will be able to:

- a. Administer holistic health care to persons in the community and / or hospital – through promotive, preventive and restorative services.

- b. Assume the nursing roles of caregiver, teacher, supervisor, researcher and manager in academic and clinical settings.
- c. Respond to the social and health needs of our country (especially our state).
- d. Be a responsible citizen in society.

8. COURSES OFFERED

2.	Bachelor of Science in Nursing: B Sc (N)	4 years (I- VIII semesters)

9. AFFILIATION

The **Basic B Sc Nursing** program is a 4-year programme comprising of eight semesters; and has been affiliated to the Odisha University of Health Sciences and recognized by the Indian Nursing Council (INC) and Odisha Nurses and Midwives Registration Council (ONMRC).

10. SEAT AVAILABILITY

Bachelor of Science in Nursing – **20 (17+3) seats**

As per the directive of the Government of Odisha, 85% of seats (17) will be through the Government quota, 15% (3) seats will be in the Management quota.

11. ELIGIBILITY CRITERIA

General eligibility criteria for B Sc (N) candidates are as given below.

- i. Be of minimum 17 years of age as on 31.12.2025. Maximum age limit for admission shall be 35 years
- ii. Be medically fit to undergo the course
- iii. Be either domicile/permanent resident/ native of Odisha.
- iv. Has passed Odia up to ME standard (only for Govt. Quota candidates)
- v. Has studied in Odisha and passed 10+2 in Science (Physics, Chemistry & Biology) from CHSE, Odisha or any other board or Council or University equivalent thereof.
- vi. Has passed in the subject of PCB & English individually and must have obtained a minimum of **45%** marks taken together in PCB at the qualifying examination i.e. (10+2).
- vii. Having passed English as a mandatory subject at the 10+2 level
- viii. For candidates belonging to SC/ST, the marks obtained in PCB taken together in qualifying examination be **40%** instead of **45%** as stated above.

Additional criteria for candidates in the Management Quota (after common counseling):

In addition to the Eligibility Criteria No. i to viii as above - admission is normally open only to-

- ix. Lady candidates, preferably single, who have had their education in Odisha.
- x. Children of Staff of Christian Hospital, Bissamcuttack (with 5 years service)/ Members of Jeypore Evangelical Lutheran Church/ Christian candidates (for a duration of at least 5 years before application) and endorsed by the appropriate authority.

12. ADMISSION / SELECTION PROCESS

- i. All candidates seeking to join the College of Nursing, CHB (CON, CHB) should apply to the Government of Odisha counseling process.
- ii. Candidates who also seek to be considered for the Management Quota and fulfill the eligibility criteria listed above, should additionally also apply to CON, CHB for the same in the prescribed form available in the College office and submit all required documents as

listed.

A. Seats of Govt Quota:

- i. Admission for Government quota will be based on State counseling
- ii. Lapsed seats, if any, from the Govt quota will be filled by the Management
- iii. As per the directive of the Govt of Odisha, candidates selected at the Counseling have to pay the stated amount immediately to the respective colleges.

B. Seats of Management Quota:

- i. All the candidates should appear for the government administered Common Entrance test
- ii. Management Quota seats will be reserved for the following categories:
 - a. Children of CHB staff (1)
 - b. Members of the Jeypore Evangelical Lutheran Church (1)
 - c. Christian Candidates (1)
- iii. CHB reserves the right to admit students who fulfill the eligibility criteria to the Management Quota, as per the decision of the Management.

C. Entrance exam for Management quota:

- i. CHB will undertake selection of the Management Quota students through a Suitability Assessment, which includes written assessment exam, Bible test, aptitude test and interviews. (The rank of the candidate in the government merit list will be considered in the selection to the management quota.)
- ii. According to merit, the Provisional Selection List will be prepared & displayed.

D. Medical Checkup

- i. Candidates listed on the Provisional list, shall deposit a sum of Rs. 2600/- towards cost of Health Check-Up (which includes X-Ray, Lab tests, vaccinations, Dental, Eye & Physical checkup, etc.)
- ii. All candidates need to be medically cleared by CHB doctors also before admission.

E. Confirmation of Seat: The following criteria are to be fulfilled for seat confirmation.

- i. Medical clearance by the CHB doctors
- ii. **Payment of Rs 20000/-**
- iii. Reporting to College of Nursing, CHB - as per Government schedule.
- iv. Submission of all required original certificates and photocopies to the College.
- v. Submission of Agreement document (also agreeing to the Prospectus and Rules and Regulations) duly signed by the candidate and parents on a Rs. 100/- stamp paper.

F. THE DECISION OF THE SELECTION COMMITTEE WILL BE FINAL

G. More information

- i. For genuine reasons, the Management will have the right to deny admission to any candidate even if otherwise eligible
- ii. The parents or legal guardians must accompany the candidate on the day of admission and sign up the formal agreement.
- iii. The wait-listed candidates are advised to check their position with the Principal before leaving

13. FEES

The Annual Fees for each year is as follows:

- a. Amount stated by the Government is to be paid at time of selection/counseling towards

- the seat.
- b. Rs 40,000 is to be paid at time of reporting / joining hostel at the commencement of the course
- c. The remaining fees can be paid through the college website: www.conchb.ac.in
- d. The fees may be paid as a lump sum or in installments as above as the semester. Fees are to be paid using the allotted Roll Number given by the College.
- e. If any student discontinues the course, after closing admission, she/he must pay the full fee for the remaining course (4 years). Transfer & Completion (as well as other original) certificates will be released only after payment of the total fee.
- f. Fee structure mentioned in the Prospectus is liable to be changed as per govt. or university directives.

14. COURSE

- a. Syllabus / course content is as directed by the Indian Nursing Council (INC), Odisha University of Health Sciences and the DMET / Directorate of Nursing, Odisha.
- b. The training course begins as stipulated by the Government of Odisha (on or about 1st October each year). Textbooks and instructions will be in English.
- c. Vacation will be granted each year at a time convenient to the institution.
- d. In the following instances students will **not** be permitted to continue the course. Those who:
 - i. Do not make the minimum grade in the internal assessment
 - ii. Are subjected to disciplinary action
 - iii. Are found medically or psychiatrically unfit by CHB medical staff.
 - iv. Are found ragging others
 - v. Commit malpractice such as – forging signatures of staff/others
 - vi. Attempt suicide or found pregnant
 - vii. Indulge in immoral behavior
- e. When necessary, the hospital/college authorities reserve the right to extend the training period for disciplinary reasons. Any candidate whose conduct makes her/him unsuitable for nursing or who is not keeping within the discipline of this institution may be expelled with or without notice.
- f. Students will be posted in the clinical areas of hospitals (own and affiliated) and community health as specified by the INC syllabus in rotation.

15. CURRICULUM / SYLLABUS

The B Sc (N) curriculum being followed is from the Indian Nursing Council. It is a four-year programme comprising of eight semesters and based on credit system. There are Foundational courses, Core courses and Elective courses. The subjects are as follows:

I Semester: Communicative English, Applied Anatomy, Applied Physiology, Applied Psychology, Nursing Foundation I including First Aid module

II Semester: Applied Biochemistry, Applied Nutrition and Dietetics, Nursing Foundation II including Health Assessment module, Health/Nursing Informatics & Technology

III Semester: Applied Microbiology & Infection control including safety, Pharmacology I, Pathology I, Adult Health Nursing I

IV Semester: Pharmacology II, Pathology II & Genetics, Adult Health Nursing II, Professionalism (values & Ethics)

V Semester: Child Health Nursing I, Mental Health Nursing I, Community Health Nursing I, Educational Technology/Nursing Education, Introduction to Forensic Nursing and Indian Laws

VI Semester: Child Health Nursing II, Mental Health Nursing II, Nursing Management & Leadership, Midwifery/ Obstetrics and Gynaecology Nursing I

VII Semester: Community Health Nursing II, Nursing Research & Statistics, Midwifery/ Obstetrics and Gynaecology Nursing II

VIII Semester: Internship (Intensive practicum/ residency posting)

16. ATTENDANCE

- a. 80% attendance in theory and practical is compulsory for appearing in the examination.
- b. 100% practical attendance in each of the practical areas is required before the award of diploma/degree.
- c. Days lost due to illnesses or other reasons will have to be made up at the end of the course.

17. EXAMINATIONS / DEGREE

The semester examinations are conducted by Odisha University of Health Science, Bhubaneswar. Students who have fulfilled the following will be permitted to appear for the University examinations.

- a. Fees paid up to date
- b. Required attendance
- c. Written and practical requirement submitted
- d. Minimum grade in internal assessment

Candidates who successfully pass all the examinations and have also completed ALL requirements (in practical) may apply for the Bachelor of Science in Nursing Degree to the University. This degree is eligible for licensure/ registration by the Odisha Nurses and Midwives Registration Council.

18. HOSTEL

- a. The college provides hostel accommodation only for single female candidates. Others, such as married women candidates will need to find their accommodation outside the campus.
- b. Students will not be allowed to continue in the hostel if they get married or indulge in behavior that is detrimental to others in the hostel or themselves, including self-harm and attempt at suicide.
- c. The students who are permitted to stay in the hostel should abide by the Hostel & Hospital Rules & Regulations.
- d. Normally only parents are permitted to visit students. Any other visitor should bring written permission signed by the parents. All visitors must obtain written permission from the Principal of the College of Nursing before meeting the student. For male visitors, permission may be considered, only if he brings a letter from the parent/s authorizing the visit.
- e. Visitors are not permitted to enter the hostel or to meet any other student than the one for whom permission is obtained.
- f. No student may meet visitors while on duty or during class.
- g. Generally, no telephone messages will be accepted on behalf of the students.
- h. Telephone facility is provided by the hostel warden.
- i. Students are not permitted to keep mobile phones
- j. Institution will not be held responsible for any loss during the stay in hostel.

19. RELIGIOUS ACTIVITY

Being a Christian institution, all our activities begin with seeking God for His blessings; and prayer is the starting point of the day's work.

- a. There is a morning prayer daily between 7.30 am and 8.00 am in CHB Chapel and all staff and students are expected to attend as important information is given there.
- b. Bible class is held weekly for students.
- c. On Sundays, there is an Odia service in the morning and an English service in the evening. All are encouraged to attend.
- d. Any student who does not wish to participate in the religious programs of the institution may seek exemption in writing from the Principal.
- e. Students are not permitted to perform any religious rites in any part of the premises of the institution, other than those organized by the institution
- f. Other than the organized evening hostel prayers, no other religious meetings should be organized in the hostel or college by the students.
- g. No idols or posters should be displayed by any student in the hostel or college premises.

20. GENERAL DISCIPLINE

- a. Students should be regular and punctual to class and clinical requirements.
- b. Students shall refrain from defacing or damaging college or hostel property. In case of loss of damage, the College Authorities reserve the right to take disciplinary action and impose an exemplary penalty either individually or collectively to prevent recurrences.
- c. The College Authorities, following due inquiry, has the right to expel any student whose conduct and character are not satisfactory nor in keeping with the rules of the institution
- d. Students shall attend the clinical duty in the prescribed uniform
- e. They shall wear neat and decent dress to classes and during off duty times
- f. They may wear minimum jewelry – only studs. (if necessary)
- g. Institution shall not be responsible for loss or theft of the students' valuables.
- h. Students shall become members of the Student Nurses' Association. No other membership to any other association or group is permitted, unless prior permission is obtained from the CHB Authorities.
- i. Students are strictly prohibited from getting involved in outside activities - be it religious, social, cultural or whatever, unless with prior permission from the Principal.

****The student manual provided at admission contains more detailed instructions, rules and regulations to be followed by the student during their stay in the institution.***

21. ANTI-RAGGING POLICY & COMMITTEE

According to the Supreme Court and INC guidelines, we are to constitute a committee for monitoring and as a squad of anti- ragging purposes. CHB & CON have an Anti-Ragging Policy.

Ragging means the display of noisy, disorderly conduct, doing any act which causes physical or psychological harm, or raises worry, fear, shame or embarrassment to a student at the institution. Ragging can include teasing, abusing, playing practical jokes, causing hurt to the students; also asking the student to do an act or perform something which normally the student would not willingly do.

Prohibition of Ragging – ragging within or outside the campus is strictly prohibited.

The penalty for ragging – whoever directly or indirectly commits or participates in, abets or propagates ragging within or outside the institution shall be punished with dismissal, termination of job or imprisonment or fine, according to the law of the land.

Penalty - any student found to be ragging another, or complaints found to be true shall be suspended or

terminated from the course according to the decision of the committee or the law of the land.

Complaints or information against ragging can be oral or written. The Principal, the warden or the faculty can be approached at any time for the same matter. Confidentiality will be strictly maintained. On admission, all students are required to sign an undertaking against ragging or abetting ragging.

In the event that any student is ragged, you are to immediately contact the anti-ragging squad, anti-ragging committee or the anti-ragging monitoring committee. The names and phone numbers of members in the respective committee is displayed on the notice board of the college.

According to the UGC Regulation 2023 we have formed a Student Grievance Redressal committee to consider grievance of the student. Grievance if any needs to be reported to this committee as soon as possible

22. RECREATION

The various recreation facilities of the hostel are as follows: indoor games, television, badminton and cultural programs. The Student Nurses' Association meets once a month for their activities.

23. ENGAGEMENT/MARRIAGE

In case any student gets married during the period of the training, she will not be allowed to stay in the hostel. As per the INC guidelines, there will be no special consideration for married candidates, and all training requirements will have to be adhered to.

24. TERMS AND CONDITIONS

Terms set forth are subject to alterations, additions and variations, as may be made from time to time by the College / Hospital authorities whenever they may deem it expedient or necessary or in order to comply with INC / ONMRC / University requirements.

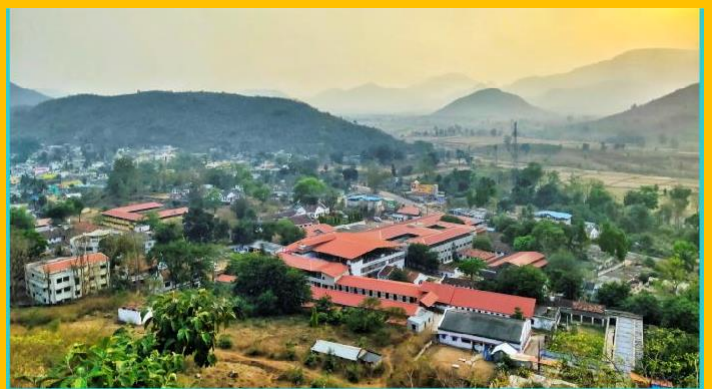
